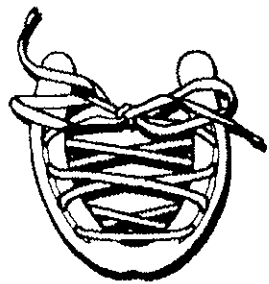

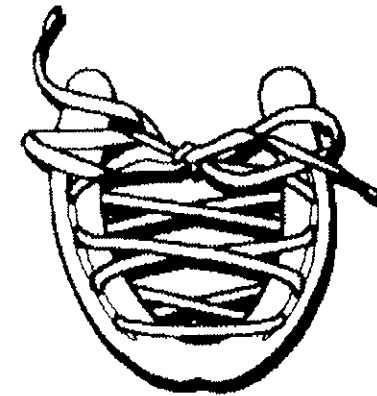

Walk/Trot and Poll Class Division

(Classes 1, 2, 3, 4) Walk-trot only. Rider/Horse Combination not to enter other Divisions. Trotting permitted in over fences classes.

Crossrail Hunter Division

(Classes 5, 6, 7, 8)

Walk-trot only. Open to riders two years of showing. Trotting permitted in over fences classes.

Novice Rider

(Classes 11, 12, 13, 14)

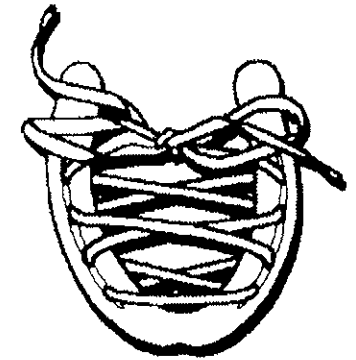
Walk-trot-canter. Open to riders/horses that have not won 6 blue ribbons in any show. Fences 2'.

Open Hunters

(Classes 16, 17, 18, 19)

Walk-trot-canter. Open to Junior Riders. Fences 2'3" - 2'6". Oxers and filled jumps permitted.

Hard hats with a securely fitting harness are required for all hunter riders whenever mounted. Junior riders must wear hats that meet the current ASTM/SEI safety standards.
